Alamo Exhibition Bird Club Vendor Registration Agreement Rules and Regulations

Vendor Set-Up Time:

Set-Up time will begin on Friday May 1st at 2pm until 7pm. Also Set-up is Available Saturday May 2nd 7:00am until 8:45 SHARP. Sorry We Can No Longer Accept Late Arrivals. We Need Time To Inspect Cages.

Loading / Unloading:

Loading or Unloading is NOT permitted through the Lobby Doors. Loading /Unloading doors CANNOT be blocked at any time. Please Secure the Door When Coming and Going to Prevent People From Entering Without Paying.

Table / Space:

Each space includes one (1) table 8 foot & two chairs. No more than two (2) vendors can share a space. EVERY VENDOR MUST SIGN THE REGISTRATION AGREEMENT. All Of your Displays, Items, and Products MUST stay WITHIN the width of your 8 foot table space. Going outside of this will result in being CHARGED for a 2nd Space. Also all table reconfiguration must be approved by the Mart Chair person.

Electricity:

\$10.00 will be charged for every electrical outlet used. Use of a multiple plug connector will be permitted. You are responsible for bringing your own electrical supplies. All extension cords must be securely taped to the floor. (Blue Masking Tape) No Sharing From Vendor to Vendor.

Cages / Birds:

All Cages Must Be Secured To Prevent Birds From Escaping &/or Children From Opening Doors. AEBC Will Provide Ties If Needed. AEBC Also Suggests Facing Doors In Towards Back Of Table. All cages, dishes and carriers must be clean & have solid bottoms. (Newspaper does not count as a Solid bottom) Excessively dirty cages and /or OVERCROWDING of birds will not be permitted. An EXAMPLE of Overcrowding would be MORE than the following birds in this size cage. In a Standard size breeding cage (18" x 24") No More than 30 Finch, 20 Parakeets and/or Lovebirds, 10 Cockatiels, 6 Quakers and/or Conures. The Mart Chair will determine said conditions.

Birds Being Displayed:

Birds that will be displayed outside of the cage MUST have their wings TRIMMED. ANY bird that becomes loose for ANY reason WILL NOT be allowed to be RETRIEVED until after 5pm and must be Caught By 6:45pm.

Escaped Birds:

Escaped/ Loose Birds For ANY Reason Is The Responsibility of The Vendor or Owner. AEBC is Not Liable. It will be your Responsibility to stay after the Mart to Retrieve Your Bird. You Will Be Held Accountable for any fees or Damages that might occur during this Process.
